

## 2022 CEMRA Non-Voting Membership Application

### Criteria General (must cover these 5 criteria)

The EFC by-laws are binding upon all members, and it is the member's responsibility to become fully acquainted with them.

- 1. Sells to the Canadian market primary through business to business and
- 2. Must be in business for under 2 years and represent a maximum of 2 two lines
- 3. Has a minimum of one employee on its payroll, residing and working in Canada
- 4. Has two existing member EFC member sponsors and
- 5. Does not knowingly support grey market and counterfeit activity

Membership is based on approval from the CEMRA Board of Directors and EFC Board of Directors.

Board members provide credible and effective insight and make decisions on the association's objectives without personal or commercial bias. Membership approval is based on the above mentioned criteria.

Please note that under special circumstances the EFC Board of Directors may grant special exception to the above qualifications.

### Manufacturer Rep

A manufacturer rep is considered as an independent agent in the electrical, electronic, factory and building automation and datacom industry. As hereinafter defined, may become a non-voting CEMRA member of Electro-Federation Canada, with the input of the CEMRA Board and the EFC Board of Directors.

#### Qualifications:

- a. Must represent at least one electrical manufacturer, and maintains a Canadian office and personnel separate and apart from, and independent of, any such manufacturers.
- b. Must be in business less than 2 years.
- c. Once the 2-line and 2-year in business minimum is established, the non-voting membership will cease and membership will translate to full voting status and applicable member dues pending CEMRA Board approval.
- d. Agreement to pay annual CEMRA non-voting membership dues of \$990 + tax, CDN.
